Dear Sir;

Recent information regarding Broward Sheriff Gregory Tony has prompted us to refer the following concerns and referrals made to us by Broward Sheriff's Office (BSO) employees and local citizens. We are concerned about Mr. Tony's mental well-being after witnessing and receiving reports of unstable behavior. His recent admission of witnessing two additional, undisclosed murders, compounded with reports from BSO employees and public observations of Tony's irrational behavior, can no longer go unaddressed. As such, we are referring these allegations to authorities for immediate review and possible employee assistance intervention.

We have received dozens of reports of Tony involved in inappropriate on-duty behavior and workplace violence to include screaming profanities and deputies, even during a funeral procession of a fallen fellow employee. Other allegations include punching walls, temper tantrums and threats to employees to include "flipping tables." These BSO employees have expressed fear of retaliation if exposed disclosing this to authorities. If true, and as Tony is currently a sworn law enforcement officer who carries a firearm and operates a government vehicle, these continued actions over the past 18 months constitute a pattern of behavior worthy of referral for anger management and workplace violence evaluations by professional medical and human resource personnel.

In his own recent admission, Tony has stated he has endured multiple psychological traumas, which may/may not be contributory to his state of mental well-being.

On October 27, 2020, Tony participated in a virtual forum hosted by Kelly Uustal attorney, Joshiah Graham, and Broward State's Attorney Office Candidate Harold Pryor. During the forum, Tony admits that he "was twelve years old when he witnessed two people gunned down in front of me" and "surviving a home invasion shooting an armed man at fourteen years of age." Tony publicly admits involvement in the shooting in 1993. He is also admitted new

information that “when I was 16 years of age when a good friend of mine, a student athlete, being shot within a few feet away from me, losing his life.” In two prior radio interviews, Tony has relayed similar information. An anonymous recent post in a law enforcement forum, albeit awaiting confirmation, has also documented additional concerns. **(Attachment A)**

We have confirmed with the District of Pennsylvania State Attorney’s Office and Philadelphia Police that they possess the records relating to these matters.

Also, it appears that these incidents have not been originally disclosed to background investigators. Again, casting doubt on the transparency of Tony’s state of mind and mental welfare.

Standard human resource protocols for law enforcement officers displaying erratic behavior, exposure following traumatic events, allegations of workplace violence and possible threats to the community would typically result in immediate assignment to administrative duties and temporary relief of their firearm and vehicle pending administrative review.

Speaking on behalf of those employees who feel they have no mechanism to report their concerns about the Sheriff, we are hoping action will be taken. In the interest of the safety of BSO employees and those Broward County citizens interacting with Tony, many times over confrontational and heated issues, we are requesting that these complaints and Tony’s possible mental health concerns be immediately addressed by human resource and professional medical personnel.

**The real Greg Tony.**

So in 1992 Greg Tony gets arrested with his brother William Ravenell for FELONY cocaine. While awaiting trial, Gregory Scott Tony shoots and kills Hector "Chino" Rodriguez as a "HIT" for Gino the local drug lord after he gives the official "OK". Gino then pays for the two top attorneys at the time to represent Greg Tony in the murder trial "cash". Philly PD quickly picks up Greg Tony as a suspect in a second Homicide.

Retired detectives confirm Greg Tony was involved in a second homicide and got him to flip. Greg Tony is then intentionally relocated to Tallahassee by the Philly PD.

He moves with his mother but resides with Sonia Colon who grew up in Philly. Sonia worked and still works at the Florida DMV and later helps Greg Tony get a job at the DMV. Coincidentally, Greg Tony receives multiple traffic citations but none of them show up on his drivers license history report. Wonder if he or Sonia had access to erase his DL history???? At the time of the NO Valid DL ticket, Greg and Sonia lived together.

Greg Tony then applies to the police academy and his disqualifying DL history never shows up in a search. He later applied to the Tallahassee PD in 2004 with a clean DL history despite a no valid DL ticket in March of 2000. When he got that ticket, he was living with Sonia Colon and was driving her car.

Tallahassee PD disqualifies Greg Tony because he admits to using LSD in the past, it because of his driving history.

Greg Tony then applies to Coral Springs PD and conveniently leaves out the fact that he NEVER tried LSD and that he had a clean DL record. What he did not know was the bad checks he passed At FSU now appeared and he had to write a letter to the then police chief stating he had NO idea writing a bad check was a crime despite appearing in front of a judge and pleading no contest just like he did with his NO Valid DL criminal citation and completing a police academy with a criminal justice degree.

Fast forward a few years and Greg Tony is asked to step down from the Coral Springs PD because he was caught sleeping on duty and selling bleed kits from his marked police car.

Greg gets appointed Sheriff Jan 11 2019 at BSO after his buddy Andrew Pollack pushes his name to then Governor elect DeSantis. Greg Passes his background check because his DL history was erased and his criminal past of murder was concealed for his willingness to testify against the shooter in the warehouse murder. Greg Never testified in that murder because the shooter was killed in a gang shooting too.

Greg then serves probation for the murder from November 1995 to January 2001. During that time his license is suspended. The NO Valid DL should have violated his probation but nothing showed in an NCIC check because of his status in Philly

Philly detectives that are familiar with the Tony family and their drug dealing have spilled the beans. Greg Tony was Involved in a second Homicide in 1995 which is verified by newspaper articles.

In a few days, people will most likely vote a convicted felon into office and then the real storm happens. The Governor is trying to make it to Election Day to keep Israel out. Candidates know this info and will be filing suit to remove him from the ballot either before the election or the day after depending on strategy.
